## Conservation Corner

The chapter would like to give a hearty thanks to the following people who responded to last issue's Conservation Classifieds: Jack Davis, who has started to move forward with expanding the Palomas Marsh enclosure and Phil Alkon, who will represent Audubon on the open space committee for Las Cruces.

We are still seeking a good **Arm Twister** to help with gathering input for the New Mexico Important Bird Area project and the **Minnow Minder**, a person who can stay abreast of developments in the saga of the silvery minnow.

Ed Mayfield and Beth Bardwell are contributing time and expertise to the development of the wetlands park at the site of the Old Refuge. Instigated three years ago by the Southwest Environmental Center, the wetlands park will be a restored native habitat of marshes, cattails, willows, cottonwoods, and more. The project is early in the planning stages and there is still time to participate in its design. The City of Las Cruces is contributing to the plans, as are the Village of Mesilla and local landowners. Thanks to Ed and Beth for carrying the Audubon message to this exciting and visionary project.

**Audubon Council News:** The Council will contribute \$300 to the NM Breeding Bird Atlas, being spearheaded by Steve Fettig of Bandolier National Monument. The Atlas will create a permanent record of the bird species breeding in the state that provides baseline data for monitoring future changes and assessing habitat needs. It will also help in land use planning by local and state governments.

Council president, Tom Jervis, is a candidate for the Valles Caldera Trust (the trust is the body that will provide guidance on the management of the Baca Ranch). Tom is a resident of Los Alamos and a retired physicist from Los Alamos National Laboratory.

Dave Henderson, the director of the Randall-Davey Audubon Center in Santa Fe, presented the Herp Bill to the NM Game Commission this month. The latest version of a reptile and amphibian protection bill first needs support of the Commission and then the Governor. The commission did not vote on including the Herp Bill in their package of bills they will forward to the Governor but they did indicate support for such a bill. Their final vote will take place at the next commission meeting on September 28<sup>th</sup> and 29<sup>th</sup> in Albuquerque. The intent of the bill is to have the NM Game and Fish Commission set possession limits for each species, beyond which a permit would be required. This should allow for future regulation of commercial take if species numbers drop below sustainable levels.

**South Valley, July 15.** Nine birders met at 6:30 AM and went on the South Valley field trip. We stopped at five sites and got a variety of birds at each place. Tim Lawton gave us a good lesson in swallows. At a place Tim knows about we were able to see Cliff, Cave, and Barn swallows all at the same time. Other highlights included Blue Grosbeak, Great Blue and Green-backed Herons, Black-crowned Night Herons, Cactus Wrens, Scott's Orioles, Western Kingbirds, and hummingbirds, along with several other species. The trip was completed by 11:30 AM.

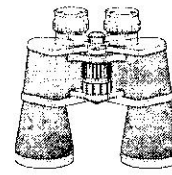

**Dripping Springs, August 19.** We had a glorious morning for our trip to Dripping Springs. Sue Hill graciously acted as co-leader. Eileen Rogers, Lorraine Schulte and a delightful couple, Nancy and Ed Stonick of Pasadena, CA rounded out the group. Ed and Nancy found us on the internet and called me last week. He is quite a good birder.

We had a successful day with 23 species, including Blue Grosbeak, Canyon Towhee, Black-chinned Hummingbird, Mourning Doves, Red-tailed Hawk, Canyon Wren, Cowbirds, Black-throated Sparrows, American Robins, Rufous-crowned Sparrows, Mockingbirds, Black-headed Grosbeak, White-winged Doves, Cactus Wrens, Black-tailed Gnatcatcher, Gambel's Quail, Scaled Quail, Warbling Vireo, Ash-throated Flycatcher, Bewick's Wren, Verdin, Phainopepla and a Curved-billed Thrasher. All in all, it was a lovely trip: good birding and good company.

## Field Trips

New Mexico's fall weather is variable. Please be prepared with layered clothing, sunscreen, and plenty of water.

**La Luz Canyon, 23 September.** In honor of the large number of MVAS members living in and around Alamo-gordo, this field trip will explore an area tucked into the base of the Sacramento Mountains. La Luz Canyon contains both desert and riparian habitats, and is some-times frequented by montane species sneaking down from the mountains. Potential highlights include Lazuli Buntings, Band-tailed Pigeons, and Common Yellowthroats. We will start from the K-Mart on Highway 70 in Las Cruces at 6:30 AM, arriving at the Texaco at the intersection of Highway 82 and the road to La Luz at 7:45. We'll leave the Texaco by 8:00, and bird until early afternoon, so bring a lunch. This won't be a strenuous field trip, as private land along most of the route will limit us to birding from the roadway. Contact Harold Harrison (522-6199) for further information.

**Chiricahua Mountains, 14 October.** We did a spring trip, we did a summer trip, now it's time for a fall trip. If you missed out on the previous trips, this is your last chance this year to visit one of the best birding spots in the country. We should see Scrub and Mexican Jays, Bridled Titmice, White-breasted Nuthatches, Acorn and Ladder-backed Woodpeckers, and many other species. This will be an overnight trip. ## Protect a Birding Hot Spot

The Army Corps of Engineers is collecting public input on potential recreational facilities east of the Las Cruces Dam, which runs for 3.5 miles paralleling Telshor, north of Lohman Ave. Two major arroyos (Alameda and Las Cruces, South and North Fork) run into this area, fill up several depressions and detention ponds, and provide excellent wetland/grassland habitat for waterfowl, shorebirds, neotropical songbirds during migration and wintering sparrows. Burrowing owls are prevalent on the escarpment; many other raptor species use the area exten-

sively. This site could be a great open space park for passive recreation (trails and wildlife viewing, as opposed to ball fields, tennis courts, etc.) and preservation of habitat.

Currently, the Corps is just producing potential recreation plans for the area; for anything to happen, the City would have to agree to a specific proposal and provide partial funding for its development (federal funding would also have to be approved by Congress). This is an excellent opportunity for the City to protect this area as the cornerstone for open space corridors along the arroyos of the East Mesa.

Please submit a brief comment on the desirability of an open space park at Las Cruces Dam. The Corps will be accepting comments for two more weeks. ### Field Trip Reports (continued from p. 2)

#### Chiricahua Mountains, August 26-27.

A maximum of eight participants braved two nights of rain in southeastern Arizona to witness the onset of migration in the Land of Cochise. Bird specialties in Cave Creek included Sulfur-bellied Flycatcher, Violet-Crowned and Calliope Hummingbirds (eight hummingbird species in all), Juniper Titmouse, and Painted Redstart. At Rustler Park there were flocks of Hermit Warblers and Pygmy Nuthatches and at Willecox over 50 Long-billed Curlews and a Marbled Godwit. The grasslands of Sulfur Springs Valley sported a Zone-tailed Hawk as well as a dark morph (or possibly Harlan's) Red-tailed Hawk. The highlight of the trip was a pair of Montezuma Quail with their brood in the oak woodland above the research station. About 75 species total. Late rains this year bode well for birding on the upcoming October trip.
